
GENERAL PURPOSE BUTYL SEALANT

With superior weather resistance and sealing properties, Manus-Bond 501-A retains its flexibility for years. Conforms with the requirements of Federal Specification TT-S-01657. 4. PACKAGING:

10.3 fl. oz. cartridges, 1, 5, & 55 gallon containers.

5. SURFACE PREPARATION:

Apply to clean, dry surfaces free of contaminants that can adversely affect adhesion. Remove all old sealant before applying 501-A.

6. PAINTING:

Cured 501-A may be painted with most industrial & commercial paints. Laboratory or field testing is recommended.

7. STORAGE LIFE:

Inspect periodically after twelve months. Store in a cool area.

8. PRECAUTIONS:

CAUTION: COMBUSTIBLE LIQUID & VAPOR. Contains mineral spirits. Keep away from heat and flame, Avoid skin contact. Wash thoroughly after handling. Avoid breathing vapor. Use with adequate ventilation. Do not take internally. See MSDS for additional information. Keep out of reach of children.
